## David,

Thanks for your work on this. Hopefully we can get something out Monday or Tuesday. Hopefully this will help us and help Ron be more clear about the boundaries as he performs his work for us and NAMB in around his gifts and passions, but in a helpful way to us over the long-term.

Some reflections on what is below....

- I like parts of the bottom paragraph.
- I agree on a short as is reasonably possible response to not create more questions and possible confusion.
- I like a more direct approach where Ron assume responsibility for the communication, not one where he is doing what we told him to do with a retraction. It feels like an announcement, not heartfelt contrition for falsely representing the BCMD. James 5:16 says with confession (not announcement) healing can begin.



- Something like... I want to apologize for my communication which created some confusion and communicated that the BCMD was involved in any way in writing or approving the article or soliciting funds for the Dollar a Day program.
- According to Jeff, Ron does not have fundraising as a part of his job. To say that Send Baltimore is raising the money, is to say that NAMB is asking for the money. Based on my understanding from Jeff, this is not under Ron's ministry description. They will have to say whether they want him raising funds for them, but if that happens, I will get back involved as it will have major implications for our work and our plans to move toward better financial stability among the BCMD churches and convention.
- My initial leanings are away from communicating the phrase that BCM/D requested a
  retraction, but I can be convinced otherwise. I am open to talking it through, not just
  giving directives, but the reality is that Ron does not speak for the BCMD and he
  mistakenly communicated that he was speaking on behalf of (mouth piece of) the
  BCMD.

I think it wise for us to get some feedback from Shannon and Sean on this matter before something is sent out. Shannon's background is in PR. Let's put our heads together on Monday or early Tuesday and hear from Kevin & Ron as well.

(BCM/D only received and "banked" the money for us as accountability partners to insure every dollar was used exclusively for church plants (not for administrative purposes or my own use in any way.) Moreover, the email does not reflect the literary and communication standards and guidelines established by BCM/D.

Consequently, the Dollar A Day campaign has been suspended. Please know that all donations already received will go to support SEND Baltimore church planting efforts only, just as promised.
